- 4. The technical Bid and Price bids must be submitted through PPMO's website: www.bolpatra.gov.np/egp; on or before **07-03-2077 12:00.** Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of bidder's representatives who choose to attend at **07-03-2077 13:00** hours at the office of Diprung Chuichumma Rural Municipality, Khotang.
- 6. Bids must be valid for a period as mentioned in table above after the bid opening and must be accomplished by a bid security issued by an authorized bank (A class Commercial Bank) (Security in the form of cash should be deposited in the deposit account A/C No. 071010020000020, A/C Name: DIPRUNG CHUI. GA.PA. DHARAUTI KHATA, Office Code no: 365000807, Name of the Bank: Sanima Bank Ltd., Diprung Branch) or scanned copy of bid security in pdf format in case of e-bid, amounting to a minimum as mentioned table above, which shall be valid for 30 days beyond the validity period of the bid.
